IMPORTANT: Safety Notice

SAFETY – RECALL – 10V-052

Dear Valued Customer,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Spartan Motors Chassis, Inc. has decided that certain incomplete fire apparatus equipped with center forward non-ABTS, which are installed on an order by order basis, fail to conform to the requirements of Federal Motor Vehicle Safety Standard No. 210, "Seatbelt Assembly Anchorages."

Please note: The Vehicle Identification Number that may be affected by this recall is located at the top of this letter.

Defect or Noncompliance:

The component used for seatbelt anchorage to the mid-section of the cab rear wall separates from the attachment point when loads less than those required by FMVSS 210 are applied. This failure could result in personnel injury.

Corrective Action:

A Spartan Motors Chassis, Inc. authorized service center will complete the recall remedy in accordance with RSB10-100-001, at no charge.

Labor Time:

The labor time required to perform the remedy is 3 hours.

What You Should Do:

Call Spartan Chassis at 800-543-5008 option 5 with your current mileage. It will then be determined if your unit is part of the recall. If so, steps will be taken to ensure the recall is performed at the nearest authorized service center. You do not need to call Spartan Chassis to

Leased Vehicles:

The lesser must notify the lessee by first class mail within ten (10) days from receipt of their owner notification letter from the manufacturer; both for the initial notification and all subsequent notifications.

Reimbursement:

If you had experienced this non-compliance and had repairs performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall. Please fill out the enclosed prepaid postcard and mail it to us if you have changed your address, sold, or traded the vehicle.
